**Vortrag: Der Helsinki-Prozess: Demokratisierung und Menschenrechte: Konsequenzen für die Menschenrechtsbildung?**

## **Abstract**

During Cold War there were two approaches reflecting separatist policies in Europe. One was institutionalized co-operation of the West, notably in the Council of Europe, based upon pluralist democracy, the rule of law and human rights. Second was Eastern European centralisation with Soviet dominance and hostility to democracy and human rights. In 1975 a bridge was built between these two separate approaches - a pan-European arrangement - the Conference on Security and Cooperation in Europe (since 1994 – OSCE).

Its another innovation was bringing together as its objectives the demands for democracy, the rule of law, human rights and other humanitarian issues which constitute the so-called human dimension (formerly a third basket). Human dimension was coupled with security in their complex interaction as a part of the concept of comprehensive security of the OSCE. It actually means that the effective achievement of one value reciprocally depends on guaranteeing the other.

However, unlike CoE and EU, the OSCE did not make requirements of respect for human rights, the rule of law and democracy among the conditions for admission of new members. Like in the UN, security considerations prevailed over those of democracy-related values. It is in this context that we need to address a dilemma of whether and how the achievement of security in Europe can better be contributed to by democratic governance.
